BACKGROUND

The California State Fair annually recognizes the accomplishments and service of key individuals or organization through a series of prestigious awards. The recipient will be publically recognized and honored at the Friends of the California State Fair Gala on Thursday, June 25, 2020.

Included here is the process for selection of this prestigious award and background of the 2020 award honoree as recommended.

AWARDS SUMMARY

Agriculturalist of the Year

The Agriculturalist of the Year award is defined as someone who has contributed extensively and in a professional capacity to the agricultural industry. Each year, the public is invited to participate in an open nomination process. The nomination process closed on January 18 and the Council met on February 19 to vote.

The Agricultural Advisory Council reviewed nominations from a total of 5 candidates and respectfully voted to recommend that **Bill & Carol Chandler** be recognized as the 2020 Agriculturalist of the Year.

Bill & Carol Chandler

Bill Chandler is a third-generation farmer in Fresno County. Bill and Carol farm near Parlier, Selma and Fowler. Their sons, John and Tom, recently joined the family farm, which was founded in the 1880s by W.F. Chandler. They grow grapes, peaches, plums, nectarines and almonds.

A graduate of U.C. Davis in agriculture production, for the past 52 years he has been the manager and partner in Chandler Farms. Bill has had a long history of involvement

in California agriculture. He has served and continues to serve and be recognized on a number of boards and commissions over the years, including:

She received her Bachelor's Degree from the University of California, Davis, and her Master's Degree from California State University, Fresno.

Carol is a past State President of California Women for Agriculture, a member of the Board of Directors of Western Growers Association, Fresno State Board of Governors, the Central Valley Community Foundation and American Agri-Women. She is also a member of the CSU Fresno Water Task Force and serves on the UC President's Advisory Commission on Agriculture and Natural Resources. Carol previously served on the California State University Board of Trustees, University of California Board of Regents, California Post-Secondary Education Commission, U.S. Department of Agriculture Advisory Committee on Emerging Markets, Grape & Tree Fruit League, and the Fresno County Fair Board.

Recognized by the California State Legislature as Woman of the Year in 1992 and 2002, Carol has further been acknowledged for her outstanding contributions to agriculture and education as the recipient of the Tapestry Award presented by Common Threads for outstanding achievements in agriculture, and as Agriculturist of the Year by the Fresno County Chamber of Commerce.

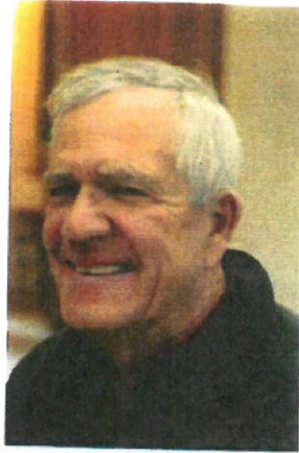

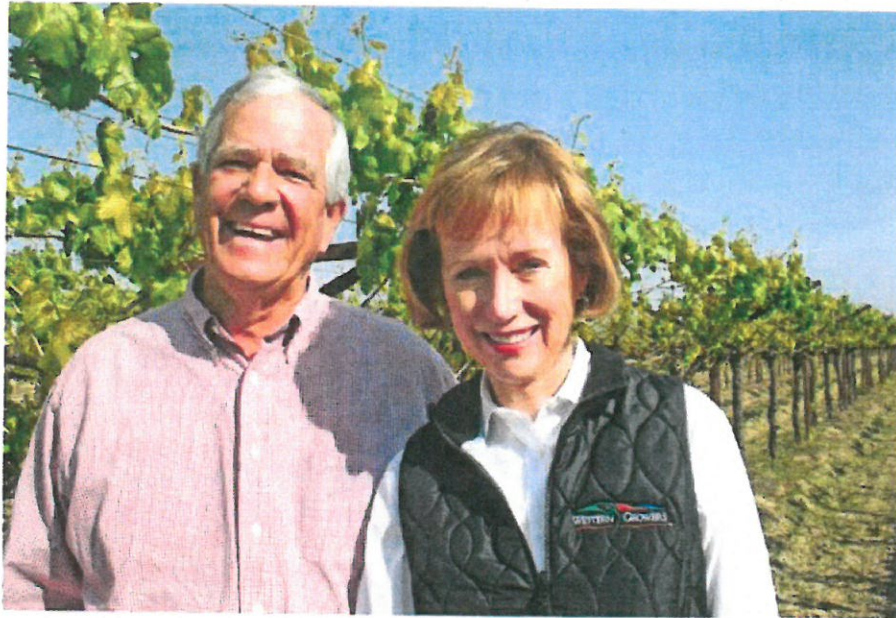

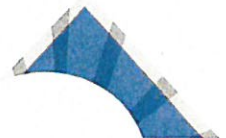

Hi Jay,

My apologies, due to travel commitments I did not get this draft to you by the deadline. But if you don't mind I would like to give you a little context for this nomination. Bill is my first cousin, once removed. He was the youngest cousin of my dad's generation who were even then 3rd generation CA farmers.

Bill and Carol are truly the dynamic duo of Central California farming. You can see this by their list of accomplishments. But their level of involvement and accomplishment did not start with Bill's generation. Barbara made mention of Bill's grandfather, my great grandfather, W.F. Chandler. He was a successful farmer in Illinois who made the treacherous crossing of the prairies and mountains to end up in Fresno County in 1882. This patriarch set the tone for Chandler family entrepreneurship and public service. He was a leader in agriculture, politics and real estate. The land for the original Fresno Airport (Chandler Field) was donated to the City of Fresno by WF Chandler.

WF had five sons, three of whom stayed in agriculture: my grandfather settled in Exeter in Tulare County and helped bring water to the South Valley by advocating for the Friant Kern Canal; Bill's dad stayed on the family homestead in Fresno County; and one moved north to pioneer the development ag land in Sutter County. One of the sons was a doctor and served as the Dean of the Stanford Medical School for 25 years; another had a distinguished career in law in Fresno. Space does not allow me to outline the accomplishments of the rest of Bill's generation, which are substantial, but you can see growing up in this family you feel an obligation to achieve great things, preserve agriculture and engage in public service.

As Bill came by this tradition honestly, he could not have a better partner in Carol. Wow is she connected! And they both are the most congenial, pleasant people you would ever want to meet. Now with their sons Tom and John back on the family farm, the tradition is assured to continue. They truly are a deserving couple for all their dedication and leadership, and what a time to recognize them!


