EXHIBITORS will be responsible for the DNA Collection for All SPECIES (Market Steers, Market Sheep, Market Barrows, Market Goats, Wether Dam & Wether Sire Sheep, Crossbred Gilts, and Wether Dam Does)

Dear Junior Exhibitor:

We are excited to announce we will be continuing our successful online DNA registration collection process for all species (Market Steers, Market Sheep, Market Barrows, Market Goats, Wether Dam & Wether Sire Sheep, Crossbred Gilts, and Wether Dam Does). Upon completing the ON-LINE DNA registration process you will receive a sample collection kit to be used for the hair sample collection procedure. DEADLINE FOR REQUESTING A KIT FOR DELIVERY VIA STANDARD US POSTAL MAIL **MAY 2, 2022**
COMPLETED SAMPLE HAIR COLLECTION **must be in our office by MAY 17, 2022**

JUNIOR WETHER DAM & WETHER SIRE SHEEP, CROSSBRED GILT & WETHER DAM DOE

DEADLINE FOR REQUESTING A KIT FOR DELIVERY VIA STANDARD US POSTAL MAIL **JUNE 1, 2022**
COMPLETED SAMPLE HAIR COLLECTION **must be in our office by JUNE 15, 2022**

No Market Animal, Sheep, Crossbred Gilt, or Wether Dam Doe entry will be eligible for official entry unless this sample is obtained and an official DNA Registration Form has been completed. **All samples will be collected by the exhibitor and a parent or leader (NO EXCEPTIONS)**. Your cancelled check and/or postage receipt will serve as your receipt. You will not receive notification from the California State Fair upon receipt of your sample.

PLEASE NOTE: This process does not enter your animal into the 2022 California State Fair, it is only a part of the necessary requirements you will need for the market division, Wether Dam/Sire Sheep, Crossbred Gilt, and Wether Dam Doe Show. All animals are required to be officially entered by the owner, pay the entry fee and do so by the official entry deadline June 15, 2022. Failure to comply with the following deadlines shall result in disqualification for competition in the 2022 California State Fair.
